**Board Activities and Announcements**

CJIN Chairman Bob Brinson called the North Carolina Criminal Justice Information Network (CJIN) Governing Board meeting to order at 9:00 AM.

Chairman Brinson welcomed the Board members and guests to the meeting and informed them that sign-in sheets were being circulated. Chairman Brinson thanked Willa Moyer and AOC CIO Jeff Marecic for sharing the facilities of the NC Judicial Center for the meeting. He also informed the Board to mark their calendars of the tentative schedule for the upcoming CJIN Board Meeting on March 26, 2015.

Chairman Brinson welcomed John Correllus, ITS Director of the Government Data Analysis Center, as the newest member to the CJIN Board. John was appointed by the State Chief Information Officer.

Chairman Brinson participated in a discussion with John Correllus.

## **CJIN Website and Facebook**

Chairman Brinson stated that the CJIN Website has been enhanced and will now include the website of every law enforcement agency in NC, along with the judicial district of each agency and a link to Court information using the AOC website.

The 2015 CJIN Annual Report will be distributed prior to our next meeting and there will be multiple workshops in February and March to gather information for the report.

Chairman Brinson participated in a discussion with LaVonda Fowler, Gene Vardaman and Tom Jarrell.

## **Ethics Awareness**

## **Project Updates, Discussion and Action Items**

Chairman Brinson informed the Board that the format of the meeting would consist of several major program updates along with five major presentations, each followed by discussions.

The Johnston County Sheriff's Office has volunteered to share with us their solution to two-factor authentication which can be used by other law enforcement agencies.

The Charlotte-Mecklenburg Police Department will provide us with an insight into their challenges with Body Worn Cameras. Then the Charlotte-Mecklenburg PD will also share with us the functionality of their very successful Real Time Crime Center. The Board has heard bits and pieces about the Center and today we will be given a presentation.

Chairman Brinson also stated there would be a discussion on advanced authentication, digital signature, single sign-on, and how the criminal justice community would benefit. Today one of the architects and subject matter experts that will provide us with an overview into the national standards – that make all these functions possible.

Chairman Brinson stated that following the presentation on National Standards, we will receive a presentation on how West Virginia is successfully implementing a state-wide credentialing system.

The meeting should be adjourned around lunch, however the out of town guests have agreed to stay and have lunch with us and reconvene back onto the meeting rooms for a workshop if there are any remaining questions on any of the presentations. Everyone is welcome to stay for lunch and the workshop following.

### **Program Update – CJLEADS**

Chairman Brinson introduced Danny Bell, who gave the Board an update on CJLEADS. Danny stated the New Release, number 12, was in December 2014. This release allowed for additional ability to search on scars, marks and tattoos will also be available as well as pistol permits search ability has been enhanced. Danny stated that there are now 28,500 users and 20.8 billion searches to date.

Danny participated in a discussion with Chairman Brinson, Al Williams, Gene Vardaman and LaVonda Fowler.

### **Program Update & Discussion - NCIS – Law Enforcement Information Exchange (LInX).**

Chairman Brinson introduced Frank Palombo who gave the Board an update on the LInX project. Frank thanked the Board for allowing him to come and give an update. LA and Chicago PD are now completely a part of LInX. Frank reviewed the Governance of how LInX operates, that funding is needed for initial connection to the system, but not for maintenance or upgrades.

Frank participated in a discussion with Chairman Brinson.

**Two-Factor Authentication, Gary Snow, Technology Manager, Johnston County Sheriff's Office**

Chairman Brinson introduced Gary Snow and Chris Strickland of Johnston County Sheriff's Office. Gary and Chris gave the Board a demonstration on the Duo Security and the two factor solution that Johnston County went with to be CJIS compliant. This solution is very cost effective and an excellent options for small to medium agencies. It is comparable with RAS for security, without the overhead.

Gary and Chris participated in a discussion with Chairman Brinson, Leslie Chaney and John McShane.

**Challenges with Body Worn Cameras, Major Steve Willis, Charlotte-Mecklenburg Police Department**

Chairman Brinson introduced Major Steve Willis of the Charlotte Mecklenburg Police Department who shared with the Board some of the challenges of body worn cameras.

The Presentation included: reasons for needing body worn cameras, time frame for roll out, the ability to have cameras record automatically when lights or sirens are activated, has a 30 second video buffer, has various mounting options, has an enhanced camera, video cannot be edited or deleted by officers, review of policies and types of calls that will be recorded, review of policy for public release, and final cost analysis and including renovations to Char-Meck PD HQ to house all the devices.

Steve participated in a discussion with Chairman Brinson, Crystal Cody, Steve Lingerfelt, Frank Palombo, Tom Jarrell, Jeff Marecic, John Maultsby, Leslie Chaney, Representative John Faircloth, LaVonda Fowler, Al Williams and Shannon Hanes.

**Overview and Functionality of the Real Time Crime Center – Charlotte-Mecklenburg Police Department, Major Steve Willis and Crystal Cody, Computer Technology Solutions Director, Charlotte Mecklenburg Police Department**

Chairman Brinson introduced Major Steve Willis and Crystal Cody, who gave the Board an overview of the Real Time Crime Center for Charlotte-Mecklenburg Police Department. Major Willis gave the Board a presentation on how the Real Time Crime Center is used to provide intelligence gathering for the Charlotte area.

Steve and Crystal participated in a discussion with Chairman Brinson, Representative Faircloth, Tom Jarrell and Crystal Cody.

**Overview of Credentialing Interoperability and National Standards that made it possible – Tom Lockwood, Senior Advisor to the Secretary of Homeland Security and Director of National Capital Region**

Chairman Brinson introduced Tom Lockwood, Senior Advisor to the Secretary of Homeland Security and Director of National Capital Region. Tom reviewed with the Board

the process by which NextGeneration ID was developed and the policies that are associated with this. Tom explained the framework of the operation in order to reduce duplication.

Tom participated in a discussion with Chairman Brinson.

#### **West Virginia's Common Credentialing Program, David Skeen, Credentialing Coordinator, West Virginia Department of Military Affairs and Public Safety (Retired West Virginia State Police)**

Chairman Brinson introduced David Skeen, Credentialing Coordinator, West Virginia Department of Military Affairs, and Public Safety. David reviewed with the Board the applications and the functionality of the Smart Card system in WV. David explained how it was developed and how it is used in WV, by citizens and law enforcement as well as military.

David participated in a discussion with Chairman Brinson.
